BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURRTON, KANSAS.

SECTION 1. That Chapter XI, Section 11-101 of the Code of the City of Burrton, Kansas is hereby changed and amended to read as follows:

INCORPORATING UNIFORM PUBLIC OFFENSE CODE. There is hereby incorporated by reference for the purpose of regulating public offenses within the corporate limits of the City of Burrton, Kansas, that certain code known as the "Uniform Public Offense Code" 2025 Edition, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. The City will keep the appropriate number copies of said Uniform Public Offense Code shall be marked or stamped "Official Copy as adopted by Ordinance No. 667," and to which shall be attached a copy of this ordinance, and filed in the City Clerk's office and open for public inspection at all reasonable office hours.

SECTION 2. Ordinance No. 657 along with any other ordinances or portions thereof in conflict herewith, are hereby repealed.

SECTION 3. This ordinance shall take effect and be in force from and after its publication once in the official designated publication site, the City of Burrton municipal website for the City of Burrton, KS.

ORDINANCE NO. 668

AN ORDINANCE AMENDING THE CODE OF THE CITY OF BURRTON, KANSAS, TO INCORPORATE BY REFERENCE THE "STANDARD TRAFFIC ORDINANCE FOR KANSAS CITIES." EDITION OF 2025 AND REPEALING ORDINANCE NO. 658 AND ANY OTHER ORDINANCE OR ORDINANCES IN CONFLICT HEREWITH.

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF BURRTON, KANSAS.

SECTION 1. That Chapter XIV, Section 14-101 of the Code of the City of Burrton, Kansas, is hereby changed and amended to read as follows:

INCORPORATING STANDARD TRAFFIC ORDINANCE. There is hereby incorporated by reference for the purpose of regulating traffic within the corporate limits of the City of Burrton, Kansas, that certain standard traffic ordinance known as the "Standard Traffic Ordinance for Kansas Cities," Edition of 2025, prepared and published in book form by the League of Kansas Municipalities, Topeka, Kansas. The City will keep the appropriate number copies of said Standard Traffic Ordinance shall be marked or stamped "Official Copy as adopted by Ordinance No. 668," and to which shall be attached a copy of this ordinance, and filed with the City Clerk to be open to inspection and available to the public at all reasonable hours. The police department, municipal judge and all administrative departments of the city charged with enforcement of the ordinance shall be supplied, at the cost of the city, such number of official copies of such Standard Traffic Ordinance similarly marked, as may be deemed expedient.

SECTION 2. Ordinance No. 658 along with any other ordinances or portions thereof in conflict herewith, are hereby repealed.

SECTION 3. This ordinance shall take effect and be in force from and after its publication once in the official designated publication site, the City of Burrton municipal website for the City of Burrton, KS.
